**RESPONDENTS' UNOPPOSED MOTION FOR EXTENSION OF TIME  
TO ANSWER THE COMPLAINT**

Counsel for Respondents Lockheed Martin Corporation (“Lockheed Martin”) and Aerojet Rocketdyne Holdings, Inc. (“Aerojet Rocketdyne”) move to extend the time for Respondents to answer the complaint in this proceeding. Currently, Respondents’ answers to the complaint are due, at the earliest, on February 8, 2022. By this motion, Respondents seek to extend this deadline until February 14, 2022. Complaint Counsel does not oppose this motion.

On January 25, 2022, Lockheed Martin accepted electronic service of the complaint in this proceeding. The Commission’s rules allow fourteen days to file an answer to a complaint, such that Respondents’ answers are due, at the earliest, by February 8, 2022. 16 C.F.R. § 3.12(a). The Administrative Law Judge may extend this deadline for “good cause shown.” 16 C.F.R. § 4.3(b).

Good cause exists to extend Respondents’ time for answering the complaint. The requested extension would more closely align with the deadline that the parties have jointly proposed in the parallel proceeding under section 13(b) of the Federal Trade Commission Act, 15 U.S.C. § 53(b). See Joint Status Report, *Fed. Trade Comm’n v. Lockheed Martin*, No. 1:22-cv-00174-RDM

(D.D.C. Feb. 4, 2022). Extending the deadline in this proceeding would promote efficiency and enable Respondents to better address the complex nature of the allegations in the complaint.

For these reasons, Respondents respectfully request that the Court enter the attached proposed Order.
